£56.5 million has already been spent in Band A of the programme between 2014 and 2019.

Band B which is the programme running now is focusing on:

- reducing the number of poor condition schools
- ensuring we have the right size schools in the right location
- providing enough places to deliver Welsh and English medium education
- ensuring the effective and efficient use of schools



Here's a photo of the new **Islwyn High**, one of the Band A projects the Council delivered



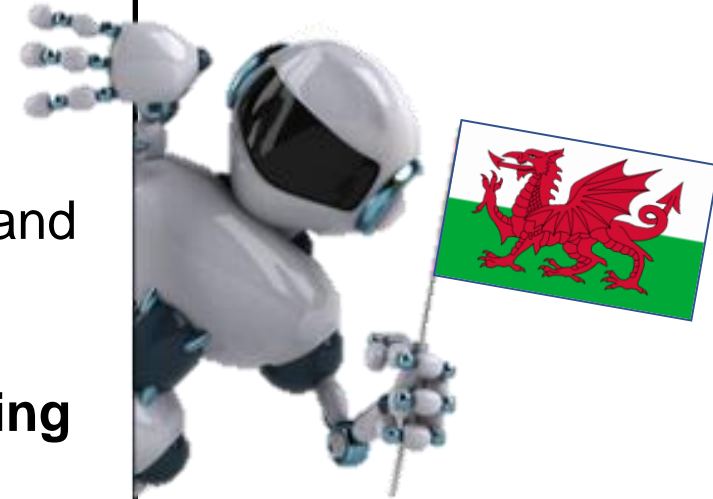
The Council has to follow a piece of law (legislation) produced by the Welsh Government called the **School Organisation Code 2018** when they want to make any changes to a school.

The Council has to write to a number of groups such as Parents, Headteachers and Staff to tell them about what they are proposing to do and gather views

The Council also needs to get your views about what we are proposing for your school as you can help us shape what will happen.

The Council are proposing to:

Relocate Ysgol Y Lawnt and Upper Rhymney Primary School

A few reasons why this is being proposed:

- The proposal seeks to create 2 new sustainable Net Zero Carbon schools on a singular site with some shared facilities, e.g. Kitchen, entrance, for both Ysgol Y Lawnt & Upper Rhymney Primary School and the wider community.
- The two schools will continue to provide both Welsh and English Medium Primary education and remain as separate entities, situated on the new dual purpose site.
- The proposal seeks to accommodate pupils in both schools between the ages of 3-11 years within their existing catchment areas through a new fit for purpose, state of the art sustainable building.
