Most of you will be aware that we have now launched our consultation document which sets out our proposals for the licensing scheme in Wales.

This is your opportunity to give us your views on our proposals and you have until 19 April to respond. We would like to encourage practitioners to complete and submit the feedback form, which can be found on the weblink above. To help you participate a number of local authorities are organising consultation workshops where Sarah Jones will be explaining the proposals:

Two local authorities (Rhondda Cynon Taff and SRS (Bridgend, Cardiff and the Vale of Glamorgan) are hosting virtual workshops and these events can be attended by any practitioner operating in Wales. If your council is not holding a workshop, you are welcome to attend one of these events:

- Rhondda Cynon Taff is hosting a virtual workshop on Tuesday 7th March 18:00 – 20:00 and SRS are in the process of confirming the dates for two workshops.
- Blaenau Gwent is holding a face-to-face workshop for their practitioners on Monday 6th March and Newport are running a similar workshop on Wednesday 8th March. Both events are being held early evening.
- North Wales councils held 3 virtual workshops on Monday 13th February.
