HYSBYSIR drwy hyn fod Cyngor Bwrdeistref Sirol Caerffili, wrth weithredu ei bwerau o dan Ddeddf Rheoleiddio Traffig Ffyrdd 1984 (fel y'i diwygiwyd), yn bwriadu, mewn nid llai na saith diwrnod o ddyddiad yr Hysbysiad hwn, wneud Gorchymyn a fydd â'r effaith o wahardd cerbydau rhag mynd ar hyd:

A4048 Pont y Siartwyr, Coed Duon, rhwng y cyffyrdd â B4251 y Stryd Fawr ac A4048 Ffordd Fenter Sirhywi. Bydd y terfyn pwysau o 7.5 tonnau ar B4251 y Stryd Fawr yn cael ei ddirymu drwy gydol cyfnod cau'r ffordd.

Disgwylir i'r Gorchymyn arfaethedig gychwyn ar 25 Mawrth 2024 am gyfnod nid yn fwy na deunaw mis neu nes bod y gwaith wedi ei gwblhau, p'un bynnag sydd gynharaf. Disgwylir i'r gwaith gael ei gwblhau erbyn 7 Ebrill 2024.

Ni fydd mynediad ar gael i'r gwasanaethau brys nac i gerddwyr. Mae'n bosibl y bydd y ffordd yn cael ei hailagor o bryd i'w gilydd, pan fo modd.

Bydd y llwybrau amgen ar hyd B4251 y Stryd Fawr, A4048 Ffordd Fenter Sirhywi, Coed Duon.

Y rheswm dros wneud y Gorchymyn yw caniatáu archwilio'r bont.

TEMPORARY PROHIBITION OF DRIVING ORDER 2024

NOTICE is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to prohibit vehicles from proceeding along:

A4048 Chartist Bridge, Blackwood between its junctions with B4251 High Street and A4048 Sirhowy Enterprise Way. The 7.5 tonne weight limit on B4251 High Street will be revoked for the duration of the closure.

The proposed Order is expected to commence on 25 March 2024 for a period not exceeding eighteen months or until the works have been completed, whichever is the earlier. It is anticipated the works will be complete by 7 April 2024.

Access for emergency services and pedestrians will not be maintained. The closure may be lifted intermittently when possible.

Alternative routes are via B4251 High Street, A4048 Sirhowy Enterprise Way, Blackwood.

The reason for making the Order is to allow for bridge inspection.

The order is required by Caerphilly County Borough Council.
